Learning Outcomes

- Apply legislation and knowledge of medicines to one's own prescribing practice.
- Critically appraise the leadership skills required for prescribing practice within the legal and professional frameworks.
- Provide a critical evaluation and synthesis of a range of prescribing theories, concepts and principles.
- To demonstrate and apply the Competency Framework relevant to your profession to evidence eligibility for registration as an independent/supplementary prescriber on the relevant governing body register.

Mode of Study

Part-time (structured): A blended approach will be adopted for teaching and learning using the university's virtual learning environment (VLE), along with eight live VC sessions for interactive learning on-line, adopting video conferencing technology to enhance learning experiences.

Study sessions

1 day a week, for the first 8 weeks- live online via Teams.

Assessment

- Pharmacology exam
- Numeracy exam
- Portfolio of evidence
